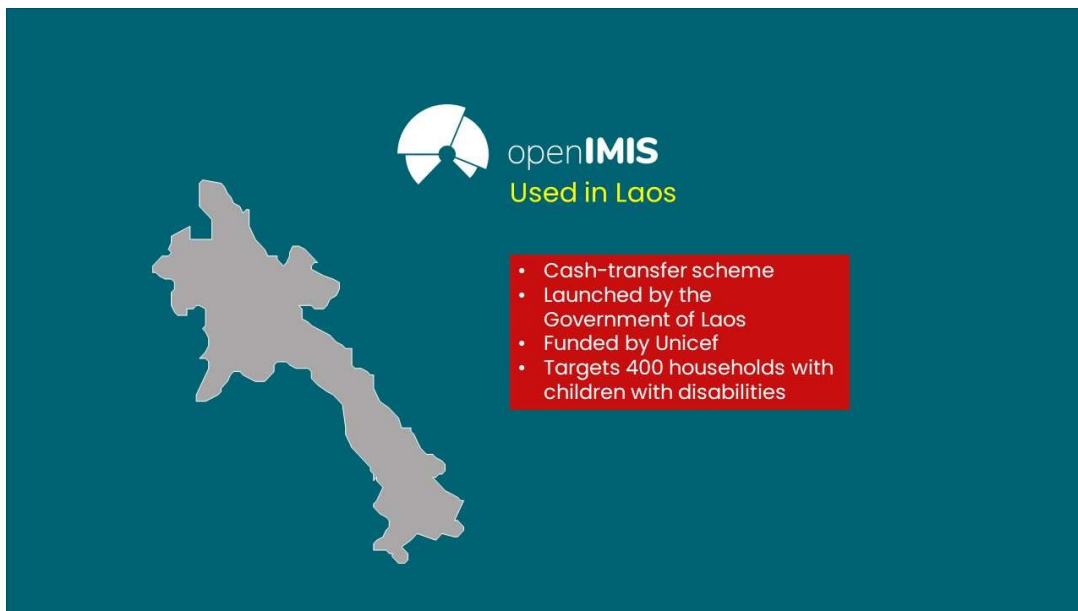

Laos manages Cash-Transfer Scheme using openIMIS

The openIMIS initiative is pleased to announce that the government of Laos has launched a pilot project managed by openIMIS for a disability cash transfer in the province of Xiengkhouang. The pilot, funded by Unicef, targets 400 households with children with disabilities. openIMIS will be used for household registration, enrollment and disbursement.
