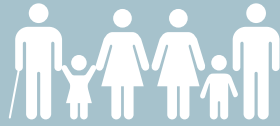

KEY FACTS

openIMIS...

- Is licensed as open source, meaning it is **free** to download, customize and use by **anybody**.
- **Data ownership** remains completely with the institution administering the system.
- Open source **doesn't mean your** data will become open.
- Can be run **without constant internet** connectivity.
- Is a **global good**. It is supported and constantly improved by a **global community**.
- Pursues the **principles of digital development** and the **digital investment principles**.

THE openIMIS INITIATIVE

- We provide technical **assistance** and experiences from different countries using openIMIS.
- We promote open **access** to technical documentation, demos and training material.
- We welcome interested institutions, supporting agencies, software developers and academia to join the peer-to-peer **exchange**.
- The initiative is funded by the Swiss and German development cooperation. The coordination desk is hosted by GIZ.

WHO SHOULD USE IT?

The users of openIMIS are institutions paying for health care, e.g. health insurance funds or ministries of health.

The software helps to manage:

- Membership/patient registry
- Benefit package (services and prices)
- Contracted providers
- Service claims and reimbursement
- Client feedback
- Monitoring and reporting

STRATEGIC PURCHASING MADE POSSIBLE

openIMIS is flexible and customizable for health systems moving towards UHC and strategic purchasing of services.

By linking patient and provider data, it allows digital information flow and processing.

openIMIS can be used for

- Health insurances schemes
- National Health Systems (tax funded)
- Output based financing: RBF and P4P
- Voucher schemes
